Mr. Wood moved that the Board of Education uphold the recommendation that Student #1091040 be expelled for the remainder of the 2007-08 school year, the 2008-09 school year and the 1st semester of the 2009-10 school year for gross misconduct and disobedience, including possession of a look-a-like weapon; trespassing, sale, distribution, use of, having or being under the influence of any drug; possession or use of tobacco; disruption of the educational process, violating Article II, B.6, B.8, B.12, B.13 and B.20.

Ms. Hoffman seconded the motion and the same was adopted by the following vote:

Mr. Ormond moved that the Board of Education uphold the recommendation that Student #1110504 be expelled for the remainder of the 2007-08 school year and the first semester of the 2008-09 school year for gross misconduct and disobedience, including major disruption of the educational process, physical violence, staff and student directed, violating Article II, B.1, B.12 and B.13.
